## **New Business**

1. 8th grade graduation - Survey recap
  - a. Administration sent out a survey to 8th grade parents gather feedback on when the parents wanted to see the 8th grade graduation events, during the work and school day or in the evening.
  - b. Admin had 75 total responses
    - i. 56 in favor of having them in the evening - 19 wanted during the day.
    - ii. Result is: Mass on Wednesday, May 16 - (5-8 graders) at around 8:15am
    - iii. Going to have graduation in the evening on Thursday, May 17 around 6:30pm. Final details will be communicated soon
    - iv. Discussed looking into a possible gift to give past board members - thanking them for their years of service. We tabled this to discuss this at our next board meeting

1. Talked about curriculum options they are going to look into the Reading and Math curriculums used in Elkhorn Public Schools. The textbook loan program is made available to us as a nonpublic school under Title IIA. We are able to access textbooks currently being used by EPS for our students.
